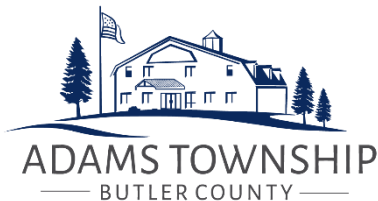
## August 16, 2018

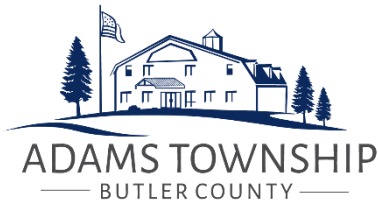
